To the fullest extent permitted by law, Contractor will defend, indemnify, and hold harmless Shannock Valley Community Festival from and against all claims, damages, losses, and expenses, of every kind, nature and description (including, but not limited to, attorneys fees, expert fees, and costs of suit), directly or indirectly arising from, or in any way related to the performance or nonperformance of Contractor's obligations under this Megan's Law Screening Certification and Listing, regardless of responsibility of negligence; by reason of death, injury, property damage, however caused or alleged to have been caused, and even though claimed to be due to the negligence of the Shannock Valley Community Festival. Provided, however, that in no event shall Contractor be obligated to defend or indemnify the Shannock Valley Community Festival with respect to the sole negligence or willful misconduct of the Shannock Valley Community Festival, its employees, or agents (excluding the Contractor, or any of its employees or agents).
